October 28th 2020 update



The news this week regarding the spread of COVID-19 throughout the state was sobering. As positivity climbs higher in the state, the experts tell us we are entering a dangerous new phase of the pandemic.

Department of Public Health Releases COVID Color alert system: The Connecticut Department of Public Health

(DPH) launched a new weekly, color-coded COVID-19 alert system for every city and town in the state, showing the average daily case rate per 100,000 population for the last two weeks and classifying number recent cases with a color-coded framework; gray (lowest recent case count), yellow, orange and red (highest recent case counts). The new weekly alert level is also accompanied by municipal-level guidance on recommended actions for individual residents, institutions such as schools, houses of worship and community organizations, plus municipal leaders and local health directors.

At this time, the town of Manchester is listed as Yellow, with 8.4 cases per 100,000 (data reported 10/4 to 10/17).

Arbors COVID Stage System: In relation to this framework, Arbors of Hop Brook has designated COVID Risk Stages Guidance, which follows the Department of Public Health Framework, as a method to communicate activity, programing and visitor guidelines appropriate to meet the level of prevalence in the community and surrounding county.

The Arbors Risk Stag Guidance will be updated and evaluated on a weekly basis. Our current stage will be posted on our community TV channel and at the entry way.

Testing Update: Based on guidance from Department of Public Health, Arbors staff and caregivers will be tested for COVID weekly. We will be offering resident COVID testing on a regular basis and more dates will be announced soon.

Vaccine Update: Based on information from the US Department of Health and Human Services, Arbors has opted to partner with CVS to provide vaccination

services to residents, which has been classified as a priority group. We are is in the beginning stages of planning for on-site vaccinations. The nation-wide vaccination service is supposed to be a 3-phase approach to vaccination based on supply availability. No more information is available or known at this time, but we will continue to provide updates as they become available.

Travel Advisory: The state's Travel Advisory directs all travelers to selfquarantine for a 14-day period when entering or returning to Connecticut from one of the identified states. Please note, the state of Connecticut does offer travelers an "opt out" of the quarantine by testing prior to travel, however, visitors to Arbors must participate in a quarantine to come onsite. This is because the tests often fail to show when someone is carrying COVID if their exposure has been very recent (e.g. during travel). They are more accurate five to seven days from exposure. Flying carries additional risks because as if requires being in a confined space with others. Travelers from other states should be advised of the 14-day quarantine requirement.

All states **with the exception of** Maine, New Hampshire, Vermont, New Jersey, Washington, Oregon, and Hawaii are part of the Connecticut travel advisory.

A Note About The Holidays and Family Gatherings: Even if there's no travel involved, gathering indoors with extended family and friends can be risky, especially for persons over 65. The Centers for Disease Control and Prevention says people 65 years and older are at higher risk for getting a severe case of COVID-19. About 80% of all deaths in the U.S. from COVID-19 have been of people in this age group.

Anthony Fauci, one of the nation's top COVID-19 medical experts and the director of the National Institute of Allergy and Infectious Diseases, has warned that coronavirus cases could spike if as families gather and celebrate indoors.

These decisions aren't easy. We are all are wanting to see loved ones and to keep up traditions. But the reality is there's no way to protect from COVID if you choose to gather with others. The safest thing to do is stay home and opt to not spend time with extended family this year.
